

“BOSCH Q3 2026 AU” PROMOTION

TERMS AND CONDITIONS

1. Instructions on how to claim and the gifts form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer, promotion, rebate, redemption, trade expo offer or special pricing arrangement.
2. The promoter is Robert Bosch (Australia) Proprietary Limited (ABN 48 004 315 628) of 1555 Centre Road, Clayton, VIC 3168, Australia, telephone 1300 30 70 37 (“**Promoter**”).
3. Claims are only open to Australian residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, Participating Stores (as defined below) and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
5. Promotion commences for purchases at 12:01am AEST on 1 July 2026 and ends for purchases at 11:59pm AEST on 30 September 2026. Claims open at 12:01am AEST on 1 July 2026 and close at 11:59pm AEDT on 14 October 2026 (“**Claim Period**”).
6. To be eligible to claim, claimants must complete the following steps:
 - a) Purchase, in a single transaction, any Eligible Product(s) from a Participating Store (defined below) during the applicable Purchase Period (“**Qualifying Purchase**”). A Qualifying Purchase does not include any clearance, run-out, liquidation, end-of-line, damaged, seconds, refurbished, ex-display, factory outlet or other specially discounted product. The Promoter reserves the right, in its sole discretion, to determine whether a product has been offered at a discounted price that renders it ineligible for this promotion; and then
 - b) Visit [Eligible Product List](#), follow the prompts to the promotion claim page, input the requested details (including but not limited to their full name, date of birth, email address, telephone number, mobile number, full street address and Participating Store where the Qualifying Purchase was made), upload a copy of their purchase receipt(s) for the Qualifying Purchase(s) to the claim form, and submit the fully completed claim form so it is received during the Claim Period.

In the event a purchase receipt is not automatically provided to the claimants by a member of staff at the time of making their Qualifying Transaction, it is the claimant’s responsibility to request such material.

7. A participating store is any retailer nationally that displays in-store or online advertising material for this promotion (each a “**Participating Store**”).
8. Multiple claims permitted, subject to the following: (a) only one (1) claim is permitted per purchase receipt regardless of the number of Eligible Products included on the purchase receipt; (b) a maximum of five (5) claims in total per person during the Promotional Period is permitted; and (c) each claim must be submitted separately and in accordance with claim requirements.

10. Certain promotions are available exclusively to individuals who are currently recognised as a trade apprentice. By redeeming these offers, claimants must confirm that they are an eligible apprentice. The promoter reserves the right to request proof of apprenticeship status at any time. If proof cannot be provided, the offer may be withdrawn or cancelled.
11. Successful claimants will be notified by email.
12. Other than instore bonus items / gifts, all gifts will be delivered to the residential address of the claimant as specified on the claim form. Delivery of the gift can take up to eight (8) weeks from the date a claim is verified and approved as valid. If a staff member of a Participating Store does not automatically hand the relevant instore bonus item / gift to the valid claimant, it is the claimant's responsibility to request the instore bonus item / gift.
14. Incomplete or indecipherable claims will be deemed invalid. Claims relating to cancelled or returned purchases will also be invalid.
15. Claimants must provide a digital copy of the original invoice/receipt from the store of purchase with their online redemption claim form to verify their claim in the promotion. The invoice/receipt must specify the store of purchase, the invoice/receipt number, the Eligible Product/s purchased and that the purchase was made during the Purchase Period but prior to submitting the claim. Failure by a claimant to upload an eligible invoice/receipt for each claim, may in the absolute discretion of the Promoter, result in invalidation of all of the claimant's claims and forfeiture of any right to a gift(s).
16. The Promoter reserves the right, at any time, to verify the validity of claims and claimant's (including a claimant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the claim process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
17. If there is a dispute as to the identity of a claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the claimant.
18. The Promoter's decision is final and no correspondence will be entered into.
19. If for any reason a claimant does not take a gift at/by the time stipulated by the Promoter, then the gift will be forfeited.

20. If any gift is unavailable, the Promoter, in its discretion, reserves the right to substitute the gift (or that part of the gift) with a gift to the equal value and/or specification.
21. Gifts are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified.
22. Any ancillary costs associated with redeeming a gift card are not included. Any unused balance of a gift card will not be awarded as cash. Redemption of a gift card is subject to any terms and conditions of the issuer including those specified on a gift card.
23. Claimants consent to the Promoter using their name, likeness, image and/or voice in the event they are a successful claimant (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.
24. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, pandemic, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any claimant; or (b) to modify, suspend, terminate or cancel the promotion, as appropriate.
25. Any cost associated with accessing the promotional website is the claimant's responsibility and is dependent on the Internet service provider used. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
27. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by a claimant; or (f) taking/use of a gift.
28. The Promoter and its officers, employees, related bodies corporate and agents will not be responsible for any incorrect, inaccurate or incomplete information received or not received in the course of or in connection with this promotion if the deficiency is occasioned by any cause outside the Promoter's reasonable control including but not limited to technical malfunctions or failures.
29. All claims become the property of the Promoter. The Promoter collects personal information about claimants to enable claimants to participate in this promotion. If personal information is not provided, the claimant may not participate in this promotion. By submitting a claim for this promotion, claimants agree that: (i) the Promoter may disclose their personal information provided to third parties, including but not limited to agents, contractors, its related bodies corporate, service providers, and gift suppliers and if required, to Australian regulatory authorities; and (ii) the Promoter and its related bodies corporate may for an indefinite period, unless otherwise advised, use the information for promotional, marketing, publicity, research and

profiling purposes, including sending electronic messages or telephoning the claimants. The Privacy Policy also contains information about how claimants may opt out, access, update or correct their personal information, how claimants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. Personal information may be stored in the Promoter's data centres in Singapore and Germany.
