TERMS AND CONDITIONS

- 1. Instructions on how to claim and the gifts form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
- 2. The promoter is Robert Bosch (Australia) Proprietary Limited (ABN 48 004 315 628) of 1555 Centre Road, Clayton, VIC 3168, Australia, telephone 1300 30 70 37 ("**Promoter**").
- 3. Claims are only open to Australian residents aged 18 years or over.
- 4. Employees (and their immediate families) of the Promoter, Participating Stores (as defined below) and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

Eligible Products include 12V 18V and 240V Bosch Professional Power Tools ("Eligible Products"). Refer to Annexure A for a full list of Eligible Products; and then

A participating store is any retailer nationally that displays advertising material for this promotion (each a "**Participating Store**").

- 8. Measuring tools, tool bags and carry cases, bemnchtop stands, heated clothing, guide rails and accessories for plunge saws, dust attachments and accessories are not included.
- 9. Successful claimants will be notified by email.
- 10. If a Qualifying Purchase was made, the claimant's gift will be delivered to their residential address as specified on the claim form. Delivery of the gift can take up to eight (8) weeks from the date a claim is verified and approved as valid. Where a gift is delivered to a claimant's residential address, claimant's must be home to take delivery.
